#### COVID-19 at-home test kit coverage

### What are COVID-19 at-home test kits?

COVID-19 at-home test kits can be used without a healthcare provider present. They are easy to use and give fast results. People with symptoms or who have been exposed to someone with COVID-19 should be tested, even if they've been vaccinated. COVID-19 at-home test kits are available for free.

## Where can I get a COVID-19 at-home test kit?

Show your member ID card at a participating network pharmacy to receive a <u>covered</u> COVID-19 at-home test kit.

## Are all brands of COVID-19 at-home test kits covered?

- No. Covered COVID-19 at-home test kits must be authorized by the FDA for use, whether you have symptoms or not. They can be used without seeing a healthcare provider. Ask at a participating pharmacy which tests are covered.
- As of February 2022, covered COVID-19 at-home test kits include:
  - o BinaxNOW COVID-19 Antigen Self-Test
  - QuickVue At-Home COVID-19
  - InteliSwab COVID-19 Rapid Test
  - CareStart COVID-19 Antigen Home Test OTC
  - FlowFlex Covid-19 AG Home Test
  - iHealth Covid-19 AG Home Test

#### How much do I pay for COVID-19 at-home test kits?

There is no cost for covered COVID-19 at-home test kits when you get one from a participating network pharmacy.

#### I already bought a test. How do I get reimbursed?

If you bought COVID-19 at-home test kits outside of your pharmacy benefit, your cost isn't eligible for reimbursement. If you saved your receipt for a covered COVID-19 at-home test kit purchased from a network pharmacy, please work with the pharmacy to see if the charges can be submitted to your insurance.

# Besides participating pharmacies, are there other ways to get free COVID-19 at-home test kits?

At-home test kits can be ordered for free from the federal government using one of the following websites:

#### Are there limits to how many COVID-19 at-home test kits someone can get?

- Effective February 8, 2022 for **Medicaid** plans:
  - Eight at-home tests per month are covered at a network pharmacy without a prescription (one test kit may contain two tests).
  - If medically necessary, more tests will be made available with a prescription by a Medicaid-enrolled provider. The prescription must include all the same information contained on a typical prescription.

**Note:** COVID-19 at-home test kit coverage began on December 13, 2022 for Medicaid plans. This is current coverage.

- Effective February 2022 for Child Health Plus (CHP) plans:
  - Two at-home test kits are covered per week at a network pharmacy.
  - If medically necessary, additional at-home tests will be made available with a prescription. The prescription must include all the same information contained on a typical prescription.
  - If an authorized healthcare provider prescribed COVID-19 at-home test kits, those prescribed will not count against the member's weekly allotment of two at-home tests kits per week.

**Note:** COVID-19 at-home test kit coverage began on January 21, 2022 for CHP plans. This is current coverage.

- Effective February 2022 for Essential Plan:
  - Two at-home test kits are covered per week at a network pharmacy.
  - If medically necessary, additional at-home tests will be made available with a prescription. The prescription must include all the same information contained on a typical prescription.
  - If an authorized healthcare provider prescribed COVID-19 at-home test kits, those prescribed will not count against the member's weekly allotment of two at-home test kits per week.

**Note:** COVID-19 at-home test kit coverage began on January 3, 2022 for Essential Plan. This is current coverage.
